

Ballet School



Thank you for your enquiry about Dance at Rigney Bank Ballet School.

We offer lessons in Ballet, Pointe Work, Modern, Tap, limbering, Jazz and Acrobatics.

We take children from 3 years of age.

Children dance for many reasons. Dancing is an excellent form of exercise and gives confidence, poise and offers plenty of social interaction. Not all children become professional dancers but the manners and discipline, as well as the joy of movement, will touch them forever.

Each child is catered for individually. There is the opportunity for any gifted and talented children to audition to attend The Royal Ballet School outreach programme on a junior associate curriculum, the Elmhurst School for Dance on their associate programme and similar programmes at other institutions.

Rigney Bank also equips older students to further their chosen vocation of dance at places like London Studios, LIPA, L.A.B.A.N, Leeds Contemporary, The Royal Ballet School, Elmhurst School for Dance, Hammond School Chester, Italia Conti School, Doreen Bird, London Contemporary, Arts Ed, Brits School, Laine Theatre Arts, Rambert, and KS Dance.



Exams and biennial production

We hold exams at the end of every term, in one of our dance disciplines.

No exam is compulsory however they are a measure of progress. No child will ever be pressured into taking any.

Every other year we put on a School Production. Every pupil is involved in a dance routine and it is always a very exciting and special occasion.

Dance payment (reviewed annually)

Lesson fees for junior members of the school are from £3.90. Private lessons are from £14.00.

Uniform

There is a dance uniform which can be purchased at Rigney Bank Ballet School once your child has settled into their class. The price list is available in the waiting area and on our website. We also operate a 'nearly new' system where you can purchase good quality used dancewear at a reasonable price.



Safeguarding and Well-being Policy

The aims of the Safeguarding and Well-being policy are as follows:

To ensure a positive and pro-active child-centred approach to best protect all children and young people, who dance at Rigney Bank Ballet School, from maltreatment.

To develop effective child protection procedures.

To maintain high standards throughout all dancing activities.

To ensure the best outcomes for children and young people.

All children and young people have the right to be safe and to be treated with dignity and respect.

Safeguarding is everyone's responsibility.

Types of abuse include: neglect, physical abuse, sexual abuse and emotional abuse. Abuse of any kind will not be tolerated. Staff will follow the safeguarding procedures when necessary and will collaborate with other professionals and agencies as required.

Staff at Rigney Bank Ballet School will listen to any person (child, young person or adult) who wishes to talk to them regarding any concerns regarding the safeguarding and well-being of the children and young people at the school.

All personal information imparted regarding children and young people will be treated with confidentiality.

All staff at Rigney Bank Ballet School will be subject to DBS clearance and safeguarding induction.

Safeguarding induction for new staff includes copies of the Safeguarding and Well-being policy and procedures; new staff are required to read and be familiar with 'Keeping Children Safe in Education, Part 1'.

Rigney Bank has a designated safeguarding officer.

Student Adjustments

The staff here at Rigney Bank Ballet School would like all parents to note that at certain times it may be necessary to physically adjust the movements of a student during class. All genre of dance are very physical in nature and require accuracy of limb placement. This is to ensure correct posture, positioning and to prevent injury.

All younger children will be accompanied to the lavatory as and when necessary. This may mean helping to undress and redress in order to avoid accidents. Children should be able to complete their ablution unaccompanied. Always encourage your child to go before class.


Data Protection Policy
